Am in excellent health and of sufficiently stable mental state, and do not suffer from high blood pressure, weak heart, head, neck and spinal problems or any other medical conditions that could be aggravated through physical strain, and will participate entirely at own risk. I understand that the elderly may not find the game suitable. I shall disclose any known or suspected condition to the Management at any time prior to commencing the paintball game which may render myself vulnerable to any form of injury.
- 3. Agree to play paintball according to the rules and regulations, and to follow directions as explained by official facilitators of Crossfire Paintball and Singapore Discovery Centre Ltd. I agree to use any Paintball equipment in a manner, which will not cause injury or damage to myself or to others while playing.
